The United Nations General Assembly has declared 2021 the *International Year for the Elimination of Child Labour* and urged the global community to take the necessary measures to achieve Goal 8.7 of the UN 2030 Agenda on Sustainable Development. Pope Francis has called for universal responsibility in the elimination of child labour. Inspired by this call to care for the "future of the human family," we and our partners vow to give a voice to the 160 million children who suffer this unacceptable scourge. Working together, we know that things can change (*cf. Laudato Si', 13*).
